MANAGING COMMITTEE MEETING 30th AUG 2025

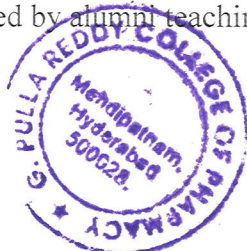
MINUTES OF THE MEETING

The Managing committee meeting of Pharma Alumni Association G.Pulla Reddy College of Pharmacy was held on 30th Aug 2025 in the Board room in college premises. The meeting was attended by President of association Dr. B. Madhava Reddy, Vice president, Mr. P. Praveen, Secretary, Dr. D.Prasanthi, Joint secretary, Mr. Krishna Chaitanya, Treasurer, Dr.Naseeb Basha Shaik, Executive members, Mr. V.Vamshee Krishna & Dr.P.Ravi Kumar.

The meeting was chaired by President of association Dr. B. Madhava Reddy and the agenda of the meeting was discussed.

- 1) Report on alumni activities--Secretary of association Dr. D. Prasanthi briefed about alumni activities.
- 2) Presenting un-audited accounts--Audited & un-audited accounts with details of fixed deposits were presented.
- 3) Contribution & sponsorship by alumni a) financial or equipment to the college--members have suggested sponsorship for equipment like computer systems & scholarship for meritorious students/ economically weaker sections. For scholarship of Rs.50,000 per year for about 4-5 students, identified & recommended by the alumni faculty based on attendance, merit and financial status.
b) sponsorship of academic prizes/ gold medal or silver medal for B.Pharm & Pharm D--Silver medal for B.Pharm and Pharm D. B.Pharm 2nd year topper alumni award amount to increase to Rs.2500 was suggested.
- 4) Raise of alumni membership fee--suggested to be increased to Rs.1000 from Sep 2025
- 5) Issue of alumni membership certificate--to be issued to members registered from 2025 onwards initially, later to others. Importance of alumni to be explained to students by alumni talk in VII / VIII Semester for B.Pharm and final year for Pharm D.
- 6) Formation of alumni chapter in USA--it was suggested to identify one person per batch, from all batches to co-ordinate with formation of association and related activities in co-ordination with Alumni association in India.
- 7) Conduct of elections for Managing committee- It was suggested to increase the managing committee members to ten as the number of passed out batches have increased. And future managing committee members to be elected as per new bye laws.
- 8) Change of by-laws- Proposal for change of bye laws of association was represented by the President of association, and changes have been accepted with some suggestions. The proposed changes will come into effect after its approval in coming General body meeting of 2025.
- 9) Any other matter - It was suggested to form a WhatsApp group of all members of alumni association, to communicate its activities.

The meeting was attended by alumni teaching staff as guest members.
