**MINUTES OF THE MEETING**

The IQAC of G. Pulla Reddy college of Pharmacy met on 18-8-2025 in board room and discussed the agenda and made the following decisions/resolutions.

1. The minutes of the previous meeting held on 02-02-2025 were read and the members approved
2. **AQAR submission for 2024-25:** Annual Quality Assurance report (AQAR) of NAAC for the academic year 2024-25 is to be submitted. However the NAAC has not enabled the AQAR submission for 2024-25, in the college login portal.  
It is decided that all the in-charges of NAAC criteria shall be ready with the data, shall be submitted as & when AQAR submission is enabled in the portal.
3. **IIQA submission for cycle 2:** The NAAC accreditation Cycle 1, started from 01-03-2021, and completing the tenure by 28-02-2026, As per the NAAC guidelines, the Institutional Information for Quality Assurance of the next cycle shall be submitted six months before the expiry of the cycle 1 accreditation.  
Accordingly , we checked the portal, for IIQA submission, still it is not enabled. We have raised Query, and the reply is still NAAC has not decided RAF or Binary grading system.

**Faculty Recruitment:** Faculty recruitment was conducted through duly constituted selection committee as per Osmania University norms and the interviews were conducted on ..... Total 3 candidates appeared interview one from each subject. Ph. Chemistry, Pharmacognosy & Pharmacology. All the three are selected. One candidate from Ph. Chemistry subject, who was already working on adhoc basis, has joined. Two more are yet to join.

**Increase in Intake for B.Pharm:** At present the intake in B.Pharm is 60. As many colleges have gone for 100 intake the matter came up in the Governing body meeting held on 11-04-2025. The Governing body suggested to assess the infrastructural facility & then go for increase. In IQAC meeting also the members suggested to go for increase in B.Pharm for 100 seats. The infrastructural facilities in terms of 4 class rooms of 50 capacity are required, However existing labs can accommodate the increase strength. The members suggested initially one class room can be created in 3<sup>rd</sup> floor. Later the remaining class rooms can constructed on 4<sup>th</sup> floor.

**UGC Autonomous status & closure of M.Pharm Ph. Chemistry course**

The Principal has informed the members, that the UGC has granted autonomous status to the college in the month of July 2025. The University has to declare the autonomous status which is expected by the end of August 2025. Once the University given the notification, the required committees shall be made as per the statutes.

The admission for the M.Ph Ph.Chemistry course are coming down during the past 3-4 years. In the academic year 2024-25 only 4 admissions took place. Therefor it is not viable.

The IQAC members also agreed for the closure of the course.










**Inclusion of New Numbers:** As the student members on IQAC completed the course & leaving the college, the member Convener shall identify the new student members & including IQAC.
